Purpose

The purpose of this privacy policy (the “Privacy Policy”) is to inform users of our Site of the following:

3. Who has access to the data collected
4. Rights of the Site users.

Consent

By using our Site, users agree that they consent to:

1. The conditions set out in this Privacy Policy
2. The collection, use and retention of the data listed in this Privacy Policy

Personal Data We Collect

We only collect data that helps us achieve the purpose set out in this Privacy Policy.

Data Collected Automatically

When you visit and use our Site, we may collect the following data automatically:

1. IP address
2. Location
3. Clicked Links
4. Content Viewed

Data Collected In Non-Automatic Ways

We may also collect the following data when you perform certain functions on our Site:



1. First and Last Name
2. Email Address
3. Phone Number
4. Physical and Mailing Address
5. Payment Information

This data will be collected when you:

1. Make a donation
2. Submit a form

How We Use Personal Data

The data we collect automatically is used to help us determine how much traffic each section of the website receives.

The data we collect when users perform certain functions may be used for:

1. To build and maintain a contact database for personal and mass communications
2. To track donations and communicate with donors

Who We Share Personal Data With

Employees and Staff

User data is available to our staff and other official members of our organization who have reasonable need to access user data to accomplish the purposes set out in this Privacy Policy.

Third Parties

For the purposes of handling user donations, we may share gift and/or personal data information with Blackbaud (our credit card processing company) and Chase Bank (our bank). Third parties cannot access data beyond what is reasonably necessary to achieve the given purpose.

Other Disclosures

We will not share or sell your data unless:

1. The law requires it
2. As required for any legal proceeding
3. To prove or protect our legal rights
4. In case of a merger or acquisition by another organization

How We Protect Your Personal Data



In order to protect your personal information, we use SSL security on the website. Your personal data, stored on a third party database, is accessible only to our employees. While we take all precautions to protect the security of our user data, there always remains a risk of a data breach. The internet by nature is not completely secure. We are unable to guarantee the security of user data beyond what is reasonably practical.

Children

We do not knowingly collect information or use personal data from children under the age of 13. If we learn that we have collected personal data from a child under the age of 13, please contact us immediately and we will remove it from our database.
